I am writing to inform you that the Board of Directors have taken the decision to close several share classes within the sub funds of the Company (each, a "Fund"). If you take no action by **11.00 am (Irish time) on 22 February 2024**, (or switch into a share class in the process of closing) we will redeem your investment with effect from 12 pm on the same day. Settlement proceeds will be sent within three working days to your bank account if we hold verified details.

Are there costs associated with the closure of the share class?

All costs directly associated with the share class closure (other than any transaction costs) will be met by the Manager, Aegon Investment Management B.V.
